Join us at the 3<sup>rd</sup> annual **Southlake Round-Up** Men's High School Lacrosse Tournament. The **Round-Up** is open to all HS-age teams, JV or Varsity. The tournament will be held in the Tradition-filled town of **Southlake, Texas** (located 15 minutes from Dallas/FW Airport) on Saturday Jan 30 and Sunday Jan 31, 2010.

The 2009 Edition of the Southlake Round-Up saw 24 teams from Texas, Oklahoma, Kansas, Louisiana, Missouri and Alberta, Canada partake in a great weekend of competitive lacrosse. At the end of play on Sunday, the Calgary Field Lax team had taken the A Division championship, while the Great Plains (KS) team had won out in the B Division.
